CHEM-KEYTM LIQUID ZINC is a complexed liquid micronutrient compound containing sulfur and zinc. It is designed for foliar and soil application for prevention and correction of zinc deficiency. It is recommended for use as an additive in liquid or dry fertilizers. It is compatible with most agricultural pesticides.

CHEM-KEYTM LIQUID ZINC tank-mixed in water will decrease alkaline hydrolysis associated with organo-

CHEM-KEYTM LIQUID ZINC is NOT RECOMMENDED for use with pesticides that are not compatible with acid materials. DO NOT MIX WITH HIGH PHOSPHATE LIQUID FERTILIZERS.

DIRECTIONS FOR USE

CHEM-KEYTM LIQUID ZINC may be applied by ground or aerial application. Use sufficient water for thorough and uniform coverage of foliage or soil. Foliar application is recommended when fast correction is desired. For best results use a non-ionic surfactant.
